191.25 NATURE RESERVE LITTER PICK

Essex Wildlife Trust local group in Brentwood has offered to assist with the organisation of a one-off litter pick for the nature reserve on 3rd December or 10th December, if the first proposed date the weather is not suitable. Local residents can be invited to assist with the litter pick with town council providing litter pickers and bags for those willing to help.
