Cllr Reynolds proposed to agree in principle to obtain quotes for improving the bar subject to the agreement of the Trustees. Cllr Browning stated that the Council would essentially be imposing contracts on the Trustees. Cllr Birch agreed it could be a liability for OTC and subsequently the Trust.

Cllr Freeman proposed to defer for four months. Cllr Browning seconded.

81/17 Membership – deferred from 22nd August 2017 meeting To consider and agree the following proposals from the Working Group:-

- a) There would be one level of Fee set at £10. This means that the Fee of £25 previously agreed for non sport participating members would be removed.
- b) Under 18 will receive free annual membership, providing that they belong to a sporting section. If they cease to be a member of a sporting section, their membership is cancelled.
- c) Introduce a card scheme under the already agreed conditions noting that this would be a forerunner to a Membership scheme operated by the OCST.

An extract from the minutes is below:-

Cllr Reynolds read out the following statement:


Prior to OTC taking over Jubilee Park in February 2015, OSSC had a membership scheme, which then was £25 per person/p. a. and was of course additional to the section fees paid by each club. Funding collected from membership primarily was used to pay for the general running expenses. Bar prices were competitive and below normal public house prices which was an inducement for being a member. Bar prices currently, are still competitive.

In August 2014, the previous OTC voted to accept a Business Plan which included membership which would provide £8,000 p.a. of fees with further projected membership bringing in an additional £3,000. This of course did not happen, as at some time the decision was made to obtain an Open Licence which came about in February 2015, and the membership revenue was lost.

Membership has been agreed already, in principle by this committee and scheduled be introduced on the 1st. September.

This decision was taken before notification was received that the Junior Football section were leaving.

We know from the Full Council meeting held on the 22nd. June that OTC cannot actually apply for a Membership Licence, however, there is no reason why sport club users cannot make an individual contribution towards paying for specific running expenses and improvements, plus, keeping the bar prices competitive.

A large number of sport club users will support the introduction of a card scheme which will assist facility running and improvement costs. The £10 initial agreed fee is minimal compared with the previous OSSC charge of £25 and would generate a minimum input of £ 1,940 based on the stated minimum number of members that each section would have to declare each year. Obviously, it would be anticipated that all section members would support the card scheme, thus providing additional necessary funding above the £1,940 stated minimum.

Users of the facility who do not play any sport but want to support the card scheme can submit their request and £10 fee to a sport section as previously agreed. This of course would be additional to the minimum number of members that each section would have to declare. Each section would submit a list of their declared, paid up members who would then receive a card, confirming receipt of payment.

The Clerk stated that membership had been referred to Full Council previously and it was refused. Cllr Birch proposed for this item to be deferred for four months. Cllr Browning seconded. Vote-
