The minutes of the meeting held on the 29th October 2015 were reviewed and agreed as a true record and signed by the chairman.

105/15 Clerk's Report

Planning application EPF/2582/15 – Mrs Jackman, 5 Shakletons, Ongar – TPO/EPF/12/08 – T1 Sycamore – Main upright stems by 3-4m to balance crown and reduce strain on stem was omitted from the planning application list for councillors to consider in error. EFDC tree officer advised the planning clerk that this application was non-contentious and would therefore be approved on officers' recommendations. Members noted and had no comments.

Proposed double yellow lines - Castle Street

As North Essex Parking Partnership have received an objection to this proposal no changes will occur and it is highly likely that an amended plan/proposal will now have to be made.

Footpath – Queensway/Fyfield Road

After a site meeting between the Council and EFDC officers it was agreed that EFDC initially obtain quotes to widen the pathway, install two solar lights, repair back fence and plant heavy shrubs along it, carry out landscaping work and remove old concrete posts to tidy the area.

- ii) EPF/1628/15 Mr Gary Brazowski, Orchard Cottage, Greensted Hall, Church Lane, Ongar Single storey rear extension. **REFUSE PERMISSION** Ongar Town Council objected to the extension will have an overpowering impact on the existing outdoor aspect of Greensted Hall and will lead to overshadowing. There are concerns over increased vehicular access in this narrow private driveway. There is insufficient information regarding the ability of the privately maintained drainage system to cope with the proposed new dwelling. The owner of Greensted Hall has raised technical issues regarding the height of the eaves on the extension and the depth of the rear extension and the council feels that these issues require clarification.
